OUR CODE OF ETHICS

- **Members should act honestly at all times**, when dealing with other members or the general public and should not let discrimination or prejudice enter into their dealings.
- **Members should NOT use their FSA membership status in commercial dealings**, where to do so could give the impression that the society is endorsing one particular product or enterprise over another.
- **Members should, at all times, refrain from any conduct that could discredit the FSA.**, protecting always, the integrity of the Society and the interests of the members/general public.
- **Members will observe good 'cyber-etiquette' at all times.** Abuse of another member or members, via our Yahoo chat site, phone calls or abusive emails to another member, will result in expulsion from the society. Flame wars are simply not tolerated.
- **Members should not omit facts or knowingly offer false descriptions when promoting products if the effect would be to mislead or misrepresent.** Specifically, members will NEVER mislead the public with regard to the cultivation, classification or appearance of any frangipani variety, where the intention may be deemed to improve its appeal for monetary gain; for example, giving the impression that seeds or seedlings offered will be the same or similar to the parent plant. Furthermore, members must endeavour to use only their OWN photographs when offering frangipanis for sale or trade, under normal circumstances. Said photographs used for sale or trade must NOT be changed or enhanced in any way, where to do so, would make the subject matter more appealing, in colour, form or create a rarity value.
- **When submitting images for inclusion in our journal "Frangipani Facts"** members should only supply THEIR OWN photographs of blooms or trees. If submitting images taken by another person is unavoidable, written permission must be obtained and forwarded to the editor, before publication can be considered. If images are not of blooms, or trees, but of events, common courtesy still dictates that prior permission is obtained before publication of photographs.
- **Members shall not make false, misleading, or deceptive claims** regarding professional qualifications or experience.
- **Members acknowledge that all CDs/DVDs purchased from FSA contain images that are copyright-protected** and will not copy or in any other way reproduce them for personal gain. This includes all copies of Frangipani Facts on CD.
